We are respectfully requesting that the R.M.T. Johnson School - Project Number TMP-009-SBQL, be considered for placement on the December 15, 2017 Priority List.

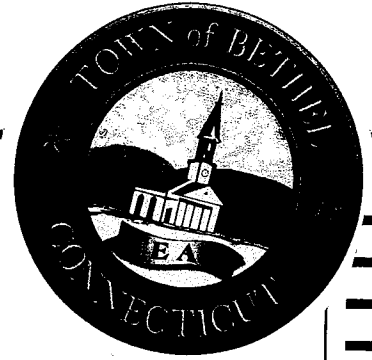
